NOTICE INVITING e-TENDERS

Separate tenders are being invited by the Principal, Krishnagar Government College, Krishnagar Nadia, through electronic tender (e-tender) for upgradation of existing Internet facilities for Office of the Principal and different departments of Krishnagar Government College, Nadia as mentioned in the attached BOQ files from eligible and resourceful vendors/bidders having sufficient credential and financial capability.

Intending vendors/bidders desirous of participating in the e-tender are to login to the website <u>www.wbtenders.gov.in</u>

Vendors/bidders willing to take part in the process of e-tender are required to obtain Digital Signature Certificate (DSC) from any of the authorized 'Certifying Authorities' (CA) under Controllerof Certifying Authorities (CCA), Department of Electronics & Information Technology (DEIT), Govt. OfIndia. DSC is given as a USB e-Token. They are required to register the fact of possessingtheDSCthrough the registration system available in the above mentioned websites. Tender is required to be submitted on-line with the help of the e Tokens. This is the only mode for esubmission of tender documents. Minimum period of time to be given to the contractors/bidders for submission of e-tenders should be counted from 19.00 hours of 12/12/2023. The relevant notice inviting tenders will be published in the college website<www.krishnagargovtcollege.org>. Last date & time of submission of e-bids online is on 29/12/2023 till 19.00 hours. The intending bidder/vendor must read the Terms & Conditions contained in the e-Notice Inviting Tender (e-NIT) carefully. He/she should particularly go through the eligibility criteria, and satisfy himself/herself of the mandatory requirements. Vendors/bidders desirous of participating in the etender may subinit e-bids for the supply of goods only if they fulfil the minimum eligibility criteria including GST registration, PAN, bank account number with IFSC Code etc. and are in possession of all the required documents.

Reputed suppliers/vendors are requested to participate in the e-tender for upgradation of existing Internet facilities for the various Departments and Office of this College. They are requested to follow eProcurement System of Government of West Bengal (https://wbtenders.gov.in/) for details. e-Tenders must be submitted during the period 12/12/2023 at 07:00 p.m. to 29/12/2023 07:00 p.m.

Before submitting the bid value, the interested suppliers/vendors are requested to visit the college premises on working days (between 12.30 pm to 1.30 pm) for detailed discussion regarding the upgradation of existing internet facility and inspection.

The suppliers/vendors are also requested to quote price as only per specifications mentioned in the BOQ files. No compliance sheet will be entertained on this very purpose.

Name of the Work:	Upgradation of existing internet facilities for the various Departments and Office of Krishnagar Govt. College.
Brief Description of requirements:	
	1. Optic Fiber Cable – (6 core)

2. Media Converter - 100MBPS

3. Eight (08)-port switch in all the departments (except Botany, Physics, Geography and Mathematics) end for internal distribution

4. Twenty four (24)-port switch in the departments of Botany, Physics, Geography and Mathematics end for internal distribution

Other Descriptions: 1. Separate optic fiber cable for each department for independent connectivity from the main hub.

2. Optic Fiber cable should be armored so that rain and heat will not destroy it.

3. Optic Fiber cable will run mainly through wall of the buildings. And where walls are not available, Optic Fiber cable will run through underground and through PVC pipe.

- 4. Buffer connectivity for each department
- 5. Job should be completed within 20days after receiving the work order.

In the technical documents, suppliers / vendors must provide self-attested photocopies of Trade license, PAN card, GST registration certificate with GSTIN Number, IT return certificate for last financial year, bank account details (cancelled cheque or 1st page of bank pass book) and one valid mobile number.

Payment of Rs. 4,000.00 (Rupees four thousand only) as Earnest Money Deposit (EMD) will be through online payment mode either through NEFT/ RTGS or NET Banking as per Finance Dept. order no. 3975F (y) dated 28.07.2016. College authority (Tender inviting authority) will not be responsible regarding refund of EMD amount. MSMEs registered in West Bengal are exempted from submission of EMD as per Finance Department, GoWB Notification 10500-F dated 19/11/2004.

Technical bids of the e-Tender will be opened on 02/01/2024 at 12:30 p.m. at the Principal's chamber. After opening of technical bids, if there is no sufficient number of supplier/vendor, then the date may be extended further. Financial bids will be opened after proper verification of technical bids.
